# HOUSING NEEDS SURVEYS



**So that we can understand you and your family's future housing needs we will be undertaking **two** housing needs surveys. One for council tenants and one for leaseholders and freeholders.**

**Leaseholders and freeholders** will be contacted in the New Year.

**Council tenants.** You should have already received a letter asking you to complete the survey. It's really important for all of you to do this as only then can we ensure that you are allocated the right sized home in the future and that the new development is planned effectively.

A Residents Steering Group already meets every month. They have been working with the council for a number of years now, understanding estate regeneration and most recently selecting Affinity Sutton as the council's estate redevelopment partner.
