We would like to increase the amount of proposed social rented floorspace so that it exceeds the existing floorspace. If we do this, we will meet the Estate Renewal objectives and further deliver on our aim to secure the future of social housing in Chelsea. The new social housing will be for our existing residents and RBKC residents. This amendment will increase the number of new homes for social rent from 237 to 270 - an increase of 33. This is possible by changing the previously proposed mews houses into homes for social rent. This will be known as the 'Revised Appeal Scheme'.

You will be able to find all the planning documents which support the **Revised Appeal Scheme** at **suttonestatechelsea.com**. These include a new design and access statement, drawings and environment assessment. We have also uploaded all of the original planning application documents under the heading **Original Planning Application/Appeal Scheme** so you can compare them.

To ensure that all parties are notified of the changes (and able to comment on them), Clarion is consulting the public until Monday 5th March. This will ensure that all stakeholders, including our residents, have the opportunity to understand and comment on the changes before the public enquiry in May. It is the changes only that are subject to this consultation.
